THE MERCHANT SHIPPING (MARITIME EDUCATION AND TRAINING FUND) (AMENDMENT) REGULATIONS, 2023

Citation GN. No. 184 of 2011 1. These Regulations may be cited as the Merchant Shipping (Maritime Education and Training Fund) (Amendment) Regulations, 2023 and shall be read as one with the (Maritime Education and Training Fund) Regulations hereinafter referred to as the "principal Regulations".

General amendment

2. The principal Regulations are amended by deleting the words "Maritime Authority" wherever they appear in these Regulations and substituting for them the word "Corporation".

Amendment of regulation 2

- 3. The principal Regulations are amended in regulation 2, by-
 - (a) deleting the definition of the term "Maritime Authority";
 - (b) deleting the definition of the term "ship" and substituting for it the following:
 - ""ship" means a floating vessel which is selfpropelled and capable of carrying passengers or cargo and includes every description of vessel used in navigation";
 - (c) in the definition of the term "vessel", adding the word "ferry" immediately after the words "sailing vessel"; and

- (d) inserting in their appropriate alphabetical order the following definitions:
- ""Corporation" means Tanzania Shipping
 Agencies Corporation established
 under the Tanzania Shipping
 Agencies Act;

"Registrar" means the Registrar appointed under section 31 of the Tanzania Shipping Agencies Act;".

"regulated services" includes any service supplied or offered for supply in maritime transport sector and includes maritime environment, safety, shipping security, port services, agency, clearing and forwarding, consolidation cargo and deconsolidation, gross mass verification and miscellaneous port services."

Amendment of regulation 4

- 4. The principal Regulations are amended in regulation 4, by-
 - (a) deleting the words "of Ships" appearing in paragraph (a) of subregulation (2).
 - (b) deleting subregulation (3) and substituting for it with the following:
 - "(3) The members specified under paragraphs (b), (d),(e), (f) and (h) of subregulation (2) shall be appointed by the Minister for a term of three years."

Amendment of regulation 5

- 5. The principal Regulations are amended in regulation 5 by deleting paragraph (f) and substitute for it the following:
 - "(f) annual contributions from regulated service as specified in the Schedule to these Regulations."
